IT PROVIDES HOUSING, BATHING FACILITIES, MEALS, CLOTHING, COUNSELING WITH A CHAPLAIN AND CASE MANAGER, REGULAR BIBLE STUDY, EDUCATIONAL SERVICES, AS WELL AS WORK THERAPY AND VOCATIONAL TRAINING. THE RESCUE MISSION'S PROGRAMS INCLUDE A ONE YEAR RESIDENTIAL NEW LIFE PROGRAM FOR MEN, AND A COMPUTERIZED LEARNING CENTER. THE MISSION SERVES FREE 2 MEALS DAILY, TOTALING OVER 187,000 MEALS A YEAR.
